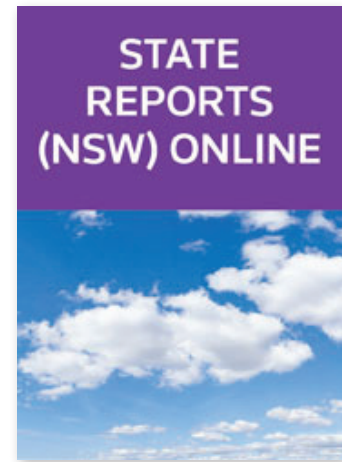


## OVERVIEW

The *State Reports (NSW)* are the authorised reports of the Supreme Court of New South Wales from 1901 to 1970.

Each full-text judgment featured in the *State Reports (NSW)* includes authored catchwords, a headnote approved by the Court, and a related PDF that is a facsimile of the authorised print version of the reports.

Thomson Reuters published the *State Reports (NSW)* from volumes 1 through to 63, with the Council of Law Reporting for NSW becoming the official publisher for volumes 64 to 72.

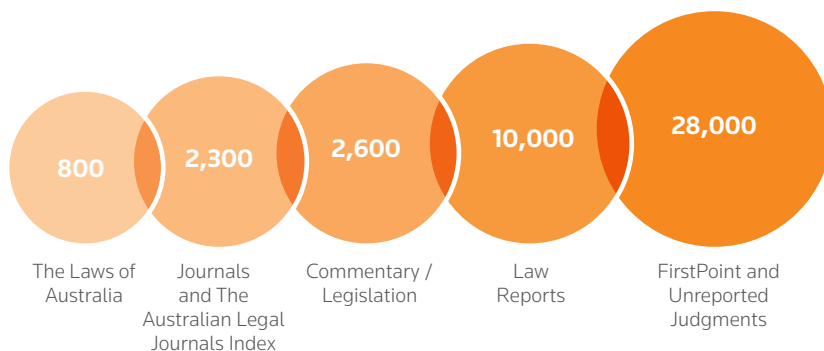
